# IN HOME DAYCARE, Tracie Lamarr

Discussion of UDO for future use, childcare family home would be permitted with special conditions in residential areas.

In the UDO the requirements- all but 1 has been met- the UDO requires a 6' opaque fence around play area. As of now there is a 3' or 4' chain link fence around play areas of back yard.

Discussion- position of home compared to street, area of it in the city, property behind the home etc. fits well as conditional use.

Kim asked what ages are currently in care?

Tracie answered she is trying to keep toddler age not babies.

Motion made to approve conditional use for in home daycare at 65 eagle street made by Todd Beene, 2<sup>nd</sup> by Kim Williams
In favor- all
Opposed- none

### MOBILE HOME at 968 Main Street

Trey stated concerns, based on our guidelines on Highway overlay district there are driveway spacing limits requiring 200' between driveways on a 55+ mph area, this driveway is less than 50' and is not in line with this guideline. 2<sup>nd</sup> UDO only allows manufactured homes in residential areas only.

Kim defined conditional use as it applies to this request, putting a mobile home in this area will decrease current property values in this area.

Recommendation requested-

Kim makes a motion to city council that we deny this application for conditional use,  $2^{nd}$  made by Glen.

In favor - 4 Opposed - none Abstained - 1

Trey recommends that we postpone voting until we are able to have a larger attendance by commissioners until possibly a special called meeting.

June 13 possible special called work night w/ Trey Foster discussing the UDO and Zoning, conditional use etc.

Commission will meet in June. We already have applications for that month.
